

## Privacy Policy

We respect the privacy of clients and visitors of our website [moeysconsulting.com](http://moeysconsulting.com)  
We ensure that the personal information you provide is treated confidentially.

### The use of personal data

When using our website “[moeysconsulting.com](http://moeysconsulting.com)”, or by telephone or written contact and when accepting an assignment, we may receive certain information from you.

The information collected through the contact form on the website, are personal data such as name, phone number and e-mail address. When accepting an assignment, all name and address details and invoice details are added.

We only store and use the personal data provided directly by you. Under no circumstances will we pass on or sell your personal data to other organizations or persons and not use it for other purposes, unless you have given prior permission for this or we may or must do so under the law or the agreement.

An exception to this is lists of participants in training. These lists, which we distribute among the participants of the relevant training, only after the start of the training and after the verbal permission of all participants, so that the participants can have mutual contact.

### Moeys Consulting collects personal data for a number of purposes:

1. Contact:

Your data will be collected when you contact Moeys Consulting via the website. However, you are only asked for the necessary information to be able to offer a proposal or a service, such as your name, email address, telephone number and subject.

2. Analytics:

The Moeys Consulting website collects your data to improve the website. This includes information such as the duration of your website visit, the pages you visit a lot, browser type, browser version and other statistics. This is done with Google Analytics. IP addresses are processed anonymously by Google so that data can never be traced back to you or your IP address. This also means that all data is anonymous and therefore not tied to your personal data.

3. Storage period:

We keep your data for a longer period of time, but never longer than is necessary for carrying out activities, unless we are required to store your data longer due to a statutory regulation.

The data that Google Analytics collects on the website is anonymous, so it is not linked to your name, company or email address. This data is stored indefinitely within Google Analytics.

## The security of your personal data.

Moeys Consulting uses careful security procedures to protect the processed data, including to prevent unauthorized access to this data. For example, we ensure that only the necessary persons have access to your data and that access to your personal data is protected.

## Cookies

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our site.

## Security

The security of your personal information is important to us, but remember that no method of transmission over the internet, or method of electronic storage, is 100% secure.

While we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.

Your visit to our website secured by an SSL certificate. This means that your connection to the Moeys Consulting website is private. You can recognize this security by the green lock in front of the url.

In addition, the Moeys Consulting domain is signed with DNSSEC. This is an extra tool that makes the "signage" of the website safer and more reliable.

## Your rights

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Moeys Consulting You also have the right to data portability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you.
